**COMPLAINT**

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Attempted Assault-3rd Degree-Substantial Bodily Harm**

Minnesota Statute: 609.223.1, with reference to: 609.17.1

Maximum Sentence: 2 1/2 years or \$5,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 06/04/2026

Control #(ICR#): 26017335

Charge Description: On or about June 4, 2026, in the County of Blue Earth, Minnesota, Alan Robert Alm did attempt to assault another and inflict substantial bodily harm.

**COUNT II**

**Charge: Drugs - 5th Degree - Possess Schedule 1,2,3,4 or paraphernalia residual - Not cannabis/hemp**

Minnesota Statute: 152.025.2(a)(1), with reference to: 152.025.4(b)

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 06/04/2026

Control #(ICR#): 26017335

Charge Description: On or about June 4, 2026, in the County of Blue Earth, Minnesota, Alan Robert Alm, did unlawfully possess one or more mixtures containing a controlled substance classified in schedule I, II, III, or IV, except cannabis flower, cannabis products, lower-potency hemp edibles, or hemp-derived consumer products or a residual amount of one or more mixtures of controlled substances contained in drug paraphernalia, and the mixture does not include any amount of a controlled substance in a fluid used in a water pipe and said controlled substance was more than .25 grams or 1 dosage unit or the defendant has a prior conviction under Chapter 152.

**COUNT III**

**Charge: Assault-5th Deg-Inflict or Attempt Bodily Harm**

Minnesota Statute: 609.224.1(2)

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 06/04/2026

Control #(ICR#): 26017335

Charge Description: On or about June 4, 2026, in the County of Blue Earth, Minnesota, Alan Robert Alm, did intentionally inflict or attempted to inflict bodily harm upon another.

## STATEMENT OF PROBABLE CAUSE

On June 4, 2026, officers the Mankato Department of Public Safety were dispatched about an individual who had visible injuries to his face. Officers responded and made contact with Victim 1.

Victim 1 had a significant amount of blood on his face and hands. Victim 1 was agitated and visibly upset. Victim 1 stated he had been struck in the head with a bottle well at Jackson Park. Victim 1 reported being hit by Alan Robert Alm, dob 2/26/1968.

Officer spoke with a witness who was at the park. The witness stated that Victim 1 had been antagonizing Alm and getting in his face. The witness stated at one point Victim 1 spit in Alm's face. The witness stated that Alm ended up grabbing a water bottle and throwing it at Victim 1's face.

Officers obtained video surveillance in the park. The video shows Victim 1 sitting on a park bench along with Alm. Victim 1 appeared to be verbally angry with Alm. Suddenly Victim 1 is seen approaching Alm. Victim 1 leans over and appears to spit on Alm. Alm then jumps off the bench and charges at Victim 1. Victim 1 deflects Alm away and Alm falls backward onto the ground.

Victim 1 then walks away and Alm pursues Victim 1. Alm then approached a metal trash bin and appeared to be trying to remove the metal lid. Meanwhile, Victim 1 is backpedaling away. Alm is then seen picking up a white metal bottle and sprinting towards Victim 1. Alm then winds up and overhand throws the bottle at Victim 1's head from about 2 to 3 feet away. Victim 1 is seen immediately grabbing his face and blood is dripping.

Alm was later located at a grocery store and arrested. On his person officers found approximately .75 grams of suspected methamphetamine.

Alm has a prior conviction for a Chapter 152 offense.

## SIGNATURES AND APPROVALS
