**COMPLAINT**

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Assault-5th Deg-2/More Prev Convict in 3 years**

Minnesota Statute: 609.224.4(b)

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 05/29/2026

**COUNT IV**

**Charge: Drugs - 5th Degree - Possess Schedule 1,2,3,4 or paraphernalia residual - Not cannabis/hemp**

Minnesota Statute: 152.025.2(a)(1), with reference to: 152.025.4(b)

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 05/29/2026

Control #(ICR#): 26016615

Charge Description: On or about May 29, 2026, in the County of Blue Earth, Minnesota, Nyaboay Gatkuoth Dang, did unlawfully possess one or more mixtures containing a controlled substance classified in schedule I, II, III, or IV, except cannabis flower, cannabis products, lower-potency hemp edibles, or hemp-derived consumer products or a residual amount of one or more mixtures of controlled substances contained in drug paraphernalia, and the mixture does not include any amount of a controlled substance in a fluid used in a water pipe and said controlled substance was more than .25 grams or 1 dosage unit.

## STATEMENT OF PROBABLE CAUSE

On May 29, 2026, officers the Mankato Department of Public Safety were dispatched to a park in Mankato, Minnesota, Blue Earth County, on report that a half-naked female was causing issues at the parking was attacking people.

Officers arrived at the park and made contact with two victims. Officers also located the suspect who was identified as Nyaboay Gatkuoth Dang (dob 3/3/1990).

Victim 1 stated that he was walking in the park when he heard some loud noises. Victim 1 observed Dang in the park. Dang approached Victim 1 and spoke with him. Victim 1 informed Dang that he called 911. Dang struck Victim 1 in the face and chest multiple times.

Witness 1 observed the incident. Witness 1 confirmed what Victim 1 said. Witness 1 also said that Dang had her breasts exposed.

Victim 2 stated that she was attacked by Dang. Specifically, Dang grabbed her face and Dang's nails dug into her face. Officers observed blood on Victim 2.

Dang appeared under the influence. She smelled strongly of alcohol and was not able to speak in complete sentences. Dang was arrested.

In a bag she was carrying with her, officers found a bubble pipe with suspected methamphetamine residue and a small baggie with approximately .71 grams of suspected methamphetamine.

Dang was convicted of 4th degree assault on November 5, 2025, in court file number 07-CR-25-3767 and convicted of 5th degree assault on November 5, 2025, in court file number 07-CR-25-1926.

## SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
