The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Domestic Assault-Felony

Minnesota Statute: 609.2242.4

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 01/31/2026

Control #(ICR#): 26003187

Charge Description: On or about January 31, 2026, in the County of Blue Earth, said Defendant, Ture Lee Hogan did, against a family or household member, as defined in M.S.A. 518B.01 Subd. 2, commit an act with intent to cause fear in another of immediate bodily harm or death and has two or more previous qualified domestic violence-related offense convictions or adjudications of delinquency within ten years following discharge from sentence or disposition for that offense.

COUNT II

Charge: 609.2242.4 Domestic Assault-Felony

Minnesota Statute: 609.2242.4

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 01/31/2026

Control #(ICR#): 26003187

Charge Description: On or about January 31, 2026, in the County of Blue Earth, said Defendant, Ture Lee Hogan did, against a family or household member, as defined in M.S.A. 518B.01 Subd. 2, intentionally inflicted or attempted to inflict bodily harm upon another and has two or more previous qualified domestic violence-related offense convictions or adjudications of delinquency within ten years following discharge from sentence or disposition for that offense.

STATEMENT OF PROBABLE CAUSE

Mankato Department of Public Safety Police Officer Joel Hermanson states that on January 31st, 2026, at approximately 11:24 p.m., he responded to a report of a domestic disturbance at a residence in the city of Mankato. A resident nearby reported hearing loud banging and slamming noises coming from the residence in question. A Dispatcher advised they received another call from Victim 1 who reported there was a male there refusing to leave the residence. Dispatch attached Victim 1 and Ture Lee Hogan to the call based on prior calls for service. Dispatch also advised that Hogan had an active warrant.

Officers Hermanson and Hickey arrived and Victim 1 later answered the door. Victim 1 denied consent for officers to search her apartment for Hogan. Victim 1 stated Hogan had left three to five minutes prior to the arrival of the officers. Hogan's coat, an item of mail, and a document with Hogan's information on it were seen near the residence. Victim 1 identified the coat as belonging to Hogan. Hogan's home address was listed the same as Victim 1.

Victim 1 initially denied a physical altercation occurred. However, upon further questioning, Victim 1 stated they were rolling cigarettes. Victim 1 did not want Hogan to take another roller paper. An argument ensued, and Hogan hugged Victim 1 tightly and Victim 1 told him to let her go. Hogan let Victim 1 go and then scratched her face with his fingernails, leaving marks, and dislodging Victim 1's nose piercing, causing minor bleeding. Victim 1 had some marks of dried blood on her hands which she stated resulted from her nose bleeding, and two long, light-red scratch marks on her right cheek which were visible to Officer Hermanson.

Victim 1 stated she and Hogan had a prior romantic relationship, where the two were together for over six months, ending around January 2025. Hogan has prior qualified domestic violence-related offense related convictions as set forth in file numbers: 83-CR-21-406; 62-CR-17-6555; 83-CR-21-216; and 07-CR-25-1491.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
