The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Aid and Abet Theft-Take/Use/Transfer Movable Prop-No Consent**

Minnesota Statute: 609.52.2(a)(1), with reference to: 609.05.1, 609.52.3(3)(a)

Maximum Sentence: 5 years or \$10,000, or both

Offense Level: Felony

Offense Date (on or about): 03/27/2026

Control #(ICR#): 26009168

Charge Description: On or about March 27, 2026, in the County of Blue Earth, Minnesota, Mohamoud Fuad Abdalla, did intentionally aid, advise, hire, counsel, or conspire with, or otherwise procure another to commit the crime, and/or did personally commit said crime; to wit: did intentionally and without claim of right take, use, transfer, conceal or retain possession of the movable property of another without the other's consent and with intent to deprive the owner permanently of possession of the property and the value of the property or services stolen exceeded \$1,000.00.

## STATEMENT OF PROBABLE CAUSE

On March 27, 2026, Officer McGuire of the Mankato Department of Public Safety learned about a past theft offense that occurred at a retail store in the city of Mankato, State of Minnesota, County of Blue Earth. Officer McGuire obtained a report written by an employee of the retail store.

The retail store employee stated that on March 27, three individuals walked into the store. Three individuals peeled off security sensor stickers from items. The individuals that hid items in their pockets left the store without paying for the items. The security sensors went off when the three suspects were leaving the store. Three suspects then fled in a vehicle.

The suspects stole \$1,133.00 of merchandise.

Officer McGuire obtained surveillance video of the suspects. Officer McGuire also obtained the license plate of the vehicle in which the suspects fled. Officer McGuire was able to identify the three suspects. One suspect was a juvenile. The two adult suspects were Abdiaziz Abdi Abdullahi, DOB 02/07/2008, and Mohamoud Abdalla, DOB 03/02/2008. Officer McGuire noted that the suspects were associated with the vehicle. Officer McGuire also compared DVS photos to the CCTV to identify the suspects.
